The World Trade Institute of the University of Bern, Switzerland and the Centre for WTO Studies, Indian Institute of Foreign Trade, India are pleased to announce the launch of the **2025 WTI – CWS Joint Academy on International Trade Law and Economic Policy (“Joint Academy”)**, which will take place in **New Delhi** from **02 June to 27 June 2025**. Since its inception in 2014, the Joint Academy has provided law students and legal professionals in India a rare opportunity to deepen their knowledge on aspects of International Trade Law and Policy. The 2024 edition of the joint Academy extended extend this exceptional opportunity to students and professionals in the field of economics. The **Joint Academy (Law)** is designed to span a comprehensive 4-week duration, while the **Joint Academy (Economics)** will span over a period of 2 weeks. Taught by distinguished academics and practitioners from India and abroad, the Joint Academy will equip participants with theoretical and practical insights into various issues relating to international trade law and policy.

WHO CAN APPLY

- All students enrolled in any law or economics course in India, either at the undergraduate or postgraduate level. Preference will be given to students who have prior exposure to issues relating to International Trade Law and Economic Policy.
- The Joint Academy is also open to Indian professionals in the field of law and economics who can attend specific modules in a flexible, “à la carte” manner. Unfortunately, this option is not available for students.
- The maximum number of participants that will be selected for the Joint Academy is 30 (thirty) (This limit applies separately to law and economics participants). *Past participants are kindly requested not to re-apply.*
- Selection of candidates is at the final discretion of the Centre.

FEES STRUCTURE

Joint Academy (Law)

For Law Students: **INR 12,000/-** (For the whole duration of the Joint Academy)

For Legal Professionals: **INR 30,000/-** (For the whole duration of the Joint Academy)

INR 8,000/- per week (For applicants applying for specific modules)

Joint Academy (Economics)

For Economics Students: **INR 6,000/-** (For the whole duration of the Joint Academy)

For Economics Professionals: **INR 15,000/-** (For the whole duration of the Joint Academy)

INR 8,000/- per week (For applicants applying for specific modules)

FINANCIAL SCHOLARSHIP

With the objective of attracting the best participation from law schools, the CWS provides a refund of course fees for law students who meet the minimum attendance criteria of 80% per week **and** attain the minimum pass percentage of 60% in each module in the Final Evaluation.

CANCELLATION POLICY

A candidate who has been accepted for the Joint Academy and has made payment in furtherance thereof may withdraw subsequently. However, such withdrawals can be made no later than May 03, 2024 and are subject to a deduction of 50% of the fees paid. No cancellations and refunds will be entertained after May 07, 2025.

ATTENDANCE AND FINAL EVALUATION

Classes are held typically 5 days a week, from 9:30 a.m. to 4:30 p.m. (Timings may differ for some modules). Participants are required to attend **all classes**. The minimum attendance requirement is 80% per week.

For evaluation, an examination will be conducted. Details about the mode of examination shall be communicated to selected participants.
